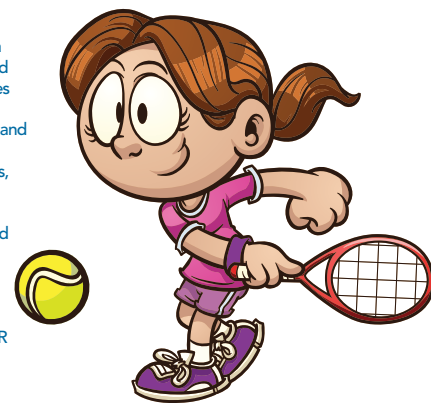

INFORMED CONSENT AND WAIVER OF LIABILITY

Parent on behalf of Parent and Child (collectively, "Releasers") fully and completely releases and forever discharges TennisKids, and each of its present and former affiliates, officers, managers, directors, agents, employees, members, insurers, attorneys and representatives (collectively, the "Releasees"), of and from any and all actions, causes of action, in law or in equity, and any suits, debts, liens, contracts, agreements, promises, liabilities, claims, demands, damages, losses, costs and expenses, of any nature whatsoever, known or unknown, suspected or unsuspected, fixed or contingent, that any of Releasees have had or now have against the Releasees arising out of or based upon Child's participation in the program. Parent authorizes TennisKids to use child's image, voice or other likeness by means of television, radio, brochures, websites, email and other media for purposes including publicity, marketing and promotion of TennisKids without compensation. Parent grants TennisKids all right, title and interest in and to such material, including any copyright or other intellectual property rights therein. Parent releases TennisKids from any liability related to such use.
